Family Fun Day Vendor Application “Avenue of Heroes” Tuesday, July 4, 2017 – 11:00am – 9:00pm

Mira Mesa’s 43rd Annual July 4th Parade and Family Fun Day is sponsored by the Mira Mesa Town Council. The Fun Day Events will be at Gil Johnson Recreation Center, 8875 New Salem Street, San Diego CA 92126. Event hours will be 11am to 9pm. Spaces are available for food trucks (at the Senior Center adjacent to the park), food vendors (no vehicles) in the park, craft, business, and community/non-profit booths. Application deadline is Saturday, June 17th, 2017.

REQUIREMENTS

- VENDORS** Copy of seller’s permit (where necessary) must be attached to applications. Non-profit Organizations please attach a copy of certification. A County Health Permit will be required for all vendors selling food. Sellers are responsible for business licenses and collecting and reporting sales tax where applicable. Please make sure that all items to be sold are listed on the application.
- FOOD VENDORS/TRUCKS APPLICATIONS** All food vendors must display all required permits to satisfy the County of San Diego food vendor laws. Must be complete of all required items and fee(s) before set-up time and specific slot is assigned. Any incomplete applications will be held until all information is submitted. All spaces will be assigned on a first-come-first-served basis
- CANCELLATIONS** There will be a 50% cancellation fee (\$50.00 minimum) for all cancellations prior to June 30, 2016. There will be no refunds after that date. There will be no refunds due to inclement weather, acts of nature, or actions by any government agency to cancel the event over which the 4th of July Committee has no control.
- SET UP** All set-up will be scheduled between the hours of 8:30 am and 10:30 am. Please make sure that you are present at your specified set-up time. Late arrivals will be required to wait until scheduled vendors are set-up. Vendors arriving after the start of the event will not be allowed to set-up. There will be no refunds for late/no-shows.
- APPS/PAYMENT** Applications may be emailed to july4th2017@xanesti.com. Checks should be made payable to Mira Mesa Town Council and sent (with application if it is not emailed) to 11075 Ice Skate Place, San Diego CA 92126. A PayPal invoice can be sent for payment if desired, but we prefer checks.
